You qualify for the **CHILD TAX CREDIT (CTC)** for any kids who were 17 or younger on December 31, 2021

If you don't have income for 2021, you still qualify for the CTC

You qualify for the **CHILD & DEPENDENT CARE CREDIT (CDCTC)** if you paid for child care in 2021 & your kids were under 13 on December 31, 2021 (as long as your child has a social security number)



You qualify for the **EARNED INCOME TAX CREDIT (EITC)** *if...*

CITIZENSHIP

For non-citizens, an ITIN (individual tax identification number) works to file your taxes & get \$\$ back in California. You don't have to have a social security number. Learn more:
